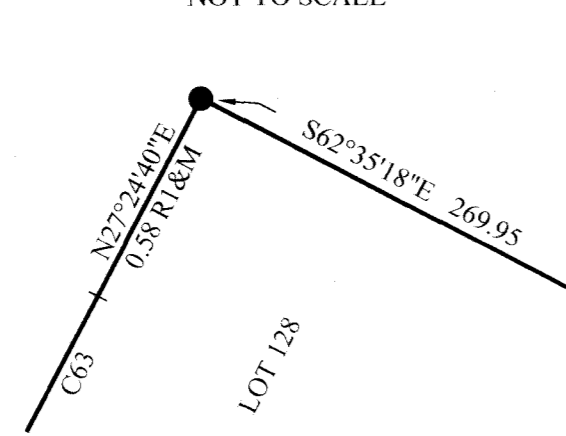

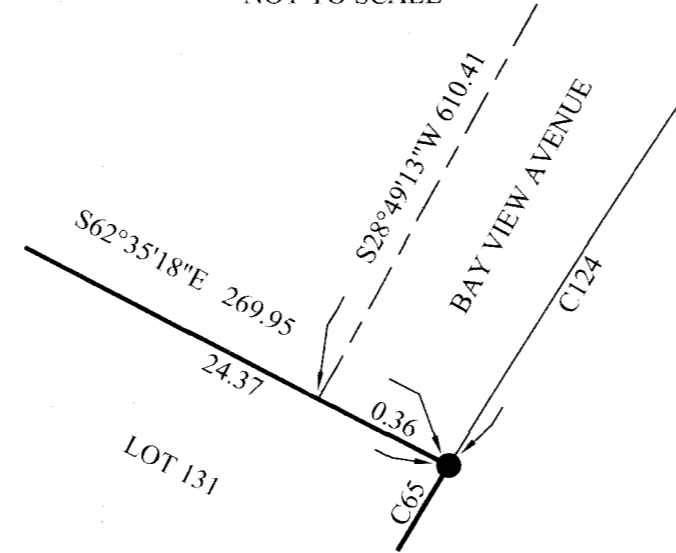

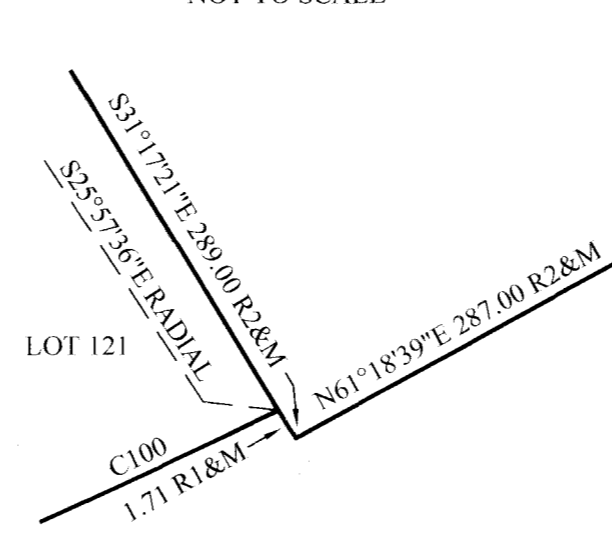
DETAIL 2 -NOT TO SCALE-



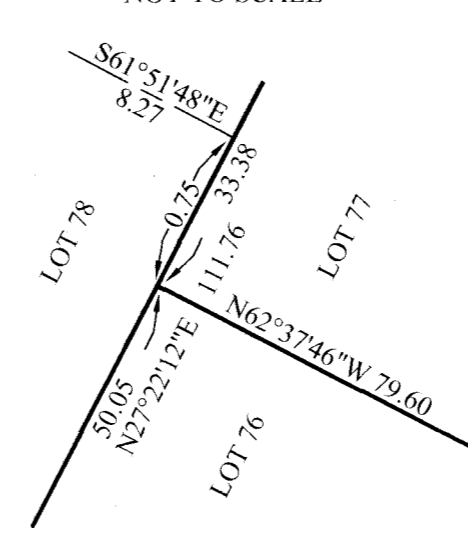
